Camping Rules and Regulations:

- 1. Registered campers will receive an confirmation email with a copy of rules, map of the facility, map of campgrounds, directions and registration details (camp site number, number of tickets purchased, dates camping).
- Each camper will get a packet with their site information and passes. Packets will need to be picked up at the gate upon arrival. Times for pick-up will be sent with your confirmation email. Failure to pick up packets will result in losing all tickets and all persons in the unit to be removed from facility.
- 3. If arrival before the dates marked on your form you will be responsible for paying the balance due before any packets may be picked up. No campers will be allowed in the campgrounds without their packets.
- 4. Vehicles must be parked either in the site with camper/tent OR in designated parking areas.
- 5. Units must be in their site by Wednesday July 16th by 8pm. Arrivals after this time must contact Rodney Keadle at 937-623-5615.
- 6. All tents and campers must be set within designated camping areas only.
- 7. No camping will be permitted from cars/trucks/vans.
- 8. All pets must be recorded on this form prior to arrival.
- 9. All pets must have record of vaccines from certified veterinarian prior to arrival on grounds. Please keep these records in your unit to access if required.
- 10. Persons using electricity must provide compatible plugs and cords. Hook-ups are subject to electrician's inspection. Expo Center is not responsible for providing adequate chords or plugs.
- 11. Golfcarts are permitted but must stay out of restricted areas. No motorized vehicles will be allowed in event area.
- 12. All premises around the camping units must be kept clean and sanitary. Trash to be placed in containers. No dumping of any holding tanks will be permitted. No gray water may be leaking from trailer. No trailers, campers, trucks, or other vehicles may be washed on the grounds using water sources on the grounds.
- 13. Fires are permitted upon prior approval and must be kept in a fire ring. Any state or local fire bans must be observed and no fires will be permitted.
- 14. Use of illegal drugs or abuse of alcohol may result in campers being asked to leave the property. No refunds of camping money will be permitted.
- 15. Abuse of the benches, picnic tables, and/or any other property belonging to the grounds may result in the person signing this agreement to be responsible for replacing at an additional charge.
